**Minimum for Localities**

- (1) That the development be carried out and completed strictly in accordance with the plans and specifications lodged with the local authority and as far as in the conditions hereunder otherwise required.
- (2) That the 10.507-acre field west of and at the west of the site be obtained from further building in connection with this proposal.
- (3) That the drainage and water supply arrangements be in accordance with the requirements of the Military Authority.
- (4) That the Building Bye-Laws approved shall be obtained (a) in order to comply with the Military Services Act, 1938 - 1944, and any conditions of such approval shall be observed in the developments.

- (2) To ensure that the development shall be in accordance with the provisions and effective control maintained.
