Indicators for Evaluation

- (1) That the development be carried out and completed in strict conformity with the plan and specifications as laid out in the specifications, save as in the case of minor deviations from the specifications.
- (2) That the program arrangements be in accordance with the requirements of the County Council.
- (3) That the national standards, including the cost, material, labor and business with the existing facilities.
- (4) That the existing program approval shall be obtained and any conditions of such approval shall be observed in the development.

- (1) To ensure that the development shall be in accordance with the general and specific objectives and objectives outlined in the plan.
- (2) In the interests of public health.
- (3) In the interests of social equity.
- (4) In order to comply with the provisions of the National Health Act.

NOTE: The use of the word "shall" in the foregoing sections (1) to (4) above regarding facilities (1) to (4) above.
