Conditions:

- (1) That the development be carried out strictly in accordance with the plans and specifications lodged with the application.
- (2) That the external finished pavement is shown on the drawings with the existing kerbs.
- (3) That building bye-laws approval shall be obtained and any conditions of such approval shall be observed in the development.
- (4) That the structure shall not be used for any purpose other than a purpose incidental to the development of the development as shown.

- (1) To ensure that the developer shall be in possession of the title plans and specifications at the time of the commencement of work.
- (2) In the interests of public safety.
- (3) In order to comply with the bye-laws of the City of Toronto, 1978-1984.
