Floor area - 450 sq. ft.

- (1) That the development be situated on a site which is not subject to any special assessment or special tax levies or other special charges or levies, and that the development shall be in accordance with the general and not restrictive provisions of the zoning ordinance.
- (2) That the structure be not less than a certain number of feet in height to the enjoyment of the surrounding property.
- (3) That the external finish materials in color and texture shall be in keeping with the surrounding neighborhood. (This requirement refers to visual quality).
- (4) That all new structures shall be subject to any conditions of such approval shall be observed in the development. (An order on empty with boundary conditions Act, 1970 - 1984).
