Proposed amendments to the Regulations under the Competition Act

Conditions

- (1) That the developer be a firm and not an individual or partnership in any other than the ordinary course of business;
- (2) That the developer and developer's agent or representative shall be a member of the Association of the City Council;
- (3) That the developer's agent or representative shall be a member of the Association of the City Council and any other person or persons shall be observed in the development.

The above conditions are subject to the provisions of the Regulations, with regard to Condition (2) above.

Terms for Conditions

- (1) To ensure that the developer shall be in accordance with the provisions and objectives of the Act;
- (2) In order to comply with the necessary requirements of the Act;
- (3) In order to comply with the necessary requirements of the Act.

The above conditions are subject to the provisions of the Regulations, with regard to Condition (2) above.
