Reasons for Planning

1. That the development be carried out and carried strictly in accordance with the plans and specification lodged with the application, save as in the conditions hereunder otherwise required.
2. That a financial contribution in the sum of £1,595, be paid by the proposers to the Council towards the cost of provision of public services in the area of the proposed development and which facilitate this development; this contribution to be paid before the commencement of development on the site.
3. That details of the foul and sewerage water drainage and water supply be approved by the Council's Sanitary Services Department, before any work is commenced on the site.
4. That the access to the site be from the location adjoining site No. 21 and that a revised plan be submitted to the Planning Department for approval.
5. That the land at the rear of the sites (1) and (3) be incorporated into the gardens of these sites.
6. That turning facilities be provided in accordance with the details shown on C.P. 141 - copy attached.
7. That the area shown as open space be reserved as public open space and levelled, scuffed, seeded and landscaped to the satisfaction of the County Council and to be available for use by residents on completion of their dwellings.
8. That no development under any permission granted pursuant to this decision be commenced until security for provision and satisfactory completion of services, including maintenance until taken-in-charge by the Local Authority of roads, open spaces, car parks, sewers, water mains or drains has been given by:-
- (a) Lodgement with the Council of an approved Insurance Company Bond in the sum of £1,000.
- (b) Lodgement with the Council of an agreed sum to be applied by the Council at its absolute discretion if such services are not duly provided to its satisfaction, on the provision and completion of such services to standard specification, and such lodgement in either case has been acknowledged in writing by the Council.
- (9) That Building Bye-Laws Approval shall be obtained and any conditions of such approval shall be observed in the development.
