**retention of an existing warehouse extension at Robinhood Road, Nass Road**

### CONDITIONS

1. Subject to the conditions of this permission the development to be carried out and completed strictly in accordance with the plans and specifications lodged with the application.
2. That the structure shall be removed on or before the 31st January, 1984 unless before that date permission for its retention is granted by the Planning Authority or by An Bord Pleanála.
3. That any necessary land required for road improvements, traversing this portion of the site be reserved as such.
4. That the requirements of the Chief Fire Officer be ascertained and strictly adhered to in the development.
5. That the applicants provide adequate sight distance and vision requirements to the eastern entrance to the site. The applicants should consult with and agree revised entrance proposals with the Roads Department, Dublin County Council.
