for the following reasons:

1. The proposed development would endanger public safety by reason of traffic hazard because of the generation of additional traffic turning movements onto the inadequate and substandard Robinhood Road in close proximity to a dangerous bend and immediately opposite the existing Industrial Estate access to Robinhood Industrial Estate.
2. The proposed future access onto the new Robinhood/Ballymount Road (the reservation for which seriously affects the site) would generate increased traffic turning movements from an individual access onto a district distributor road thereby endangering public safety by reason of traffic hazard.

When an appeal has been duly made and has not been withdrawn An Bord Pleanala will determine the application for permission as if it had been made to them in the first instance.
