That a concrete hardstanding be provided to the front of each dwelling to facilitate off street car parking. 5. That one half standard tree be provided in the front garden of each house. 6. That suitably capped and finished concrete block or brick screen walls be erected to screen rear gardens from public view at appropriate locations, as directed by the Council's Engineer. 7. That each house have a minimum front building line of 25ft. and rear garden depth of 35ft. 8. That a minimum of 7'6" be provided between each pair of houses. 9. That all relevant conditions of Order No. PA/280/80 (Reg. Ref. SA 1242) be strictly adhered to in the development.	1.
