
1. Structural drawings showing the elevations including finishes of the proposed development to a scale of not less than  $\frac{1}{8}$ " to 1ft.
2. Clarification that the requirements of the Supervising Health Inspector can be strictly adhered to in the proposed development.

NOTE : The applicant should consult with the Supervising Health Inspector before re-submitting.

3. A block plan scale 1:100 with annotated scaled dimensions showing how the applicant proposes to comply with the off street car parking requirements in accordance with the Standards laid down in the Development Plan.
