1. Subject to the conditions of this permission that the development be carried out and completed strictly in accordance with the plans and specification lodged with the application. 2. That before development commences approval under the Building Bye-laws be obtained and all conditions of that approval be observed in the development. 3. That all conditions of Dublin Corporation's specification for Small Builders be adhered to in the carrying out of this development. 4. That a concrete hardstanding be provided to the front of each dwelling to facilitate off street car-parking. 5. That one half standard tree be provided in the front garden of each house. 6. That suitably copped and finished concrete block or brick screen walls be erected to screen rear gardens from public view at appropriate locations, as directed by the Council's Engineer. 7. That each house have a minimum front building line of 15 ft. and rear garden depth of 35 ft. 8. That a minimum of 7' 6" be provided between each pair of houses. 9. That all relevant conditions of Order No. PA/300/80 (Reg. Ref. SA.1242) be strictly adhered to in the development.	1. That a financial contribution in the sum of £102,000 be paid by the proposer to the Dublin County Council towards the cost of provision of public services in the area of the proposed development and which facilitate this development.
