With reference to your planning application received here on 16th June, 1981, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate:-

- 1. The septic tank proposal is not acceptable to the Chief Medical Officer. No evidence has been submitted as to the suitability of the sail for the simple disposal of septic tank effluent and the location of the tank does not comply with the distance requirements of the Council. The applicant is asked to shownthe soil suitability by the excavation of trial holes and to clarify whither or not she can increase the size of the site or otherwise comply with the distance requirements. An acceptable septic tank design also to be submitted.
- 2. Clarification of the size and location of the land holding owned by the applicant's father in the area of the site is required.
