With reference to your planning application received here on 25th May, 1981 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate :-

1. Further information is required from the applicant which should provide for :-

- (a) Specific evidence that an adequate and potable water supply is available and its location in relation to septic tank percolation areas.
- (b) Location of adjoining septic tanks and percolation areas together with existing wells.
- (c) Specific evidence that adequate and safe access including vision splays can be provided together with provision for future road improvement reservation.
- (d) An indication of the applicant's need for housing in the area.
