With reference to your planning application received here on 1st May, 1981 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate :-

1. Further information is required which should provide for :-
 - (a) Satisfactory evidence of site suitability for the disposal of septic tank effluent. Consideration should be given to a suitable house location on the site in relation to a satisfactory septic tank location.
 - (b) Specific evidence that an adequate and potable water supply can be provided.
 - (c) Specific evidence that adequate and safe access can be provided to public road.

NOTE : The applicant should consult with the County Council with regard to the above matters before any further information is submitted.
