With reference to your planning application received here on 1st May, 1981 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate :-

1. Further information is required which should provide for :-

- (a) Clarification of the existing and proposed uses for the structure described as "side porch".
- (b) Clarification of the structural alterations to the joint party wall between Nos. 41 and 40, including height variations.
- (c) Surface water disposal arrangements
- (d) Evidence of the consent of the co-owner of the party wall to this proposal
