

**CONDITIONS**

1. Subject to the conditions of this permission that the development be carried out and completed strictly in accordance with the plans and specification lodged with the application.
2. That the 29ft. 6ins. x 3ft. illuminated panel on the south side of the building be omitted.
3. That the remaining sign be not illuminated.

**REASONS FOR CONDITIONS**

1. To ensure that the development shall be in accordance with the permission and that effective control be maintained.
2. This sign would distract the attention of drivers from the traffic lights at the Old Bawn Tallaght By-pass junction thereby endangering public safety by reason of traffic hazard.
