With reference to your planning application received here 6th August, 1980, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. The proposed storage shed appears to be proposed to be constructed over the location of the septic tank as indicated on drawing submitted with the application for outline permission M. 2236. The applicant should submit details indicating how it is proposed to comply with the requirements of the Health Inspector in relation to the septic tank drainage. The applicant is advised to consult with the Health Inspector prior to submission of details.

2. Clarification is required as to the need for such a large store being added to the existing development. Information is required as to the type of goods to be stored, the origin of the goods and the means of disposal of the goods.
