County Health District of Dublin, did by order, P/A/1543/80 dated 24/7/80

or the following reasons:
Proposed retention of translucent roofing and security roof at Tallaght,
Town Centre, Greenhills Road.

1. The proposed development which is already in use as a door store display area materially contravenes the grant of permission (by Order PL/6/5/37328 on 25/2/77) by the Parliamentary Secretary to the Minister for Local Government which envisaged that this area would be used as a landscaped pedestrian circulation area.
2. The development and the type of construction constitutes a serious fire hazard. More specifically, the development would hamper the efficiency of a fire fighting team by restricting its means of access and would also endanger the safety of persons occupying either the main structure or the newly covered area.
3. The development which is located in an area zoned "A" to preserve and improve residential amenity would be injurious to the amenities of the area because of its unsightly appearance.
