for the following reasons:

I. The proposed development which envisages a pedestrian access to the Tallaght By-Pass which has not a public footway on this frontage, would endanger public safety by reason of traffic hazard because of the generation of pedestrian movements on the carriageway at a point where an average vehicle speeds are high and because of the unacceptable generation of stopping vehicles and vehicle parking on this National Secondary Route.
