for the following reasons:

1. The proposed development would contravene materially condition no. 1 of a permission already granted by Order No. P/878/71 dated 21/4/71, which envisaged the erection of one dwelling house within this curtilage (Reg. No. C.2041)
2. The proposed development which envisages the erection of an additional dwelling house within the curtilage of an existing dwelling house would seriously injure the residential amenities of the area and would not be in accordance with the proper planning and development of the area.
