With reference to your planning application received here on 18th February, 1979, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. Further information is required which should provide for specific evidence of soil suitability for the disposal of septic tank effluent and also that the proposed septic tank drainage system can be satisfactorily located and operated on this restricted site. The applicant should discuss and agree these matters with the Health Inspector's Department before submitting further information.

NOTE: The applicant is advised to consider a more suitable extension, which will not be in close proximity to the existing public road, which is likely to be widened at some future time.
