<ol style="list-style-type: none"> 1. The development to be carried out in and completed in conformity with C.I.E. Drawing No. 131/11, 3.4.79. 2. The applicants to make satisfactory arrangements for the maintenance repair and upkeep of the structure. 3. The applicants shall accept responsibility for the removal of the structure at their own expense if such is necessary for the purpose of road widening, reconstruction or repair and for the repair, replacement and renewal of any services installed in the public street. 4. The lighting of the panels to be carried out so as not to cause excessive glare or distraction to road users or adjoining property owners and the hours of lighting shall not extend beyond the hours of lighting of the adjoining street lights. 5. The proposed bus shelter shall be relocated with its back wall along the outer face of the adjoining school boundary wall.
