APPEAL by the Board of Management of Scoil Chrónáin, Main Street, Rathcoole, County Dublin and C. Sweeney, of 14 Moyle Crescent, Clondalkin, County Dublin, against the decision made on the 7th day of March, 1980, by the Council of the County of Dublin, deciding to refuse to grant a permission for the erection of a primary school on a site adjoining Coolamber Drive, Rathcoole:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, permission is hereby refused for the erection of the said school for the reason set out in the Schedule hereto

SCHEDULE

The proposed means of vehicular access to the site from the adjoining housing estate is considered to be unsuitable to serve the proposed school and the additional traffic movements on the narrow estate roads which the proposed development would generate would endanger public safety by reason of traffic hazard
