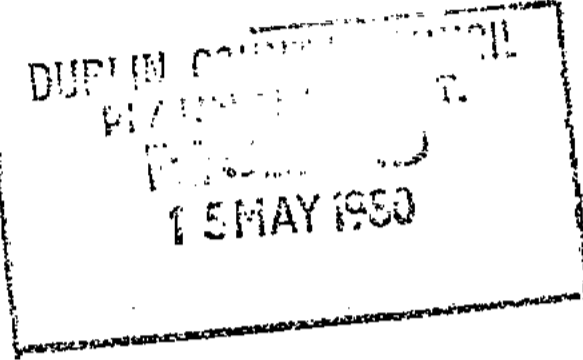

In pursuance of its functions under the above mentioned Acts the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order, P/ **A/3295/79** dated **17th December, 1979** decide to refuse:

For **proposed industrial use for land at 10, Robinhood Road, Dublin 12.**

for the following reasons:

1. The proposed development would endanger public safety by reason of traffic hazard because of the unacceptable generation of heavy vehicular traffic turning movements to and from the site on to the inadequate and substandard Robinhood Road.
2. The proposed development on this restricted site would be premature pending the construction of the future district distributor road network for this area and would not be in accordance with the proper planning and development of the area.

When an appeal has been duly made and has not been withdrawn An Bord Pleanála will determine the application for permission as if it had been made to them in the first instance.
