A PERMISSION/APPROVAL has been granted for the development described below subject to the undermentioned conditions.

Proposed supermarket premises at Killinarden, Tallaght, Co. Dublin.

### CONDITIONS

1. Subject to the conditions of this permission that the development be carried out and completed strictly in accordance with the plans and specification lodged with the application.
2. That before development commences approval under the Building Bye-Laws be obtained and all conditions of that approval be observed in the development.
3. That Condition Nos. 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 of Order No. P/1033/78, dated 7th April, 1978, (Reg. Ref. N. 2507) be adhered to in respect of this development.
4. That the supermarket floor area be reduced to 4,272 sq. ft., as previously approved by Order No. P/1033/78, dated 7th April, 1978. This reduction is to be achieved by the cutting back of part of the rearward portion shown on the plans now submitted.

1. To ensure that the development shall be in accordance with the permission and that effective control be maintained.
