With reference to your planning application received here on 12th July, 1979 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate :-

1. Further information is required which should provide for :-
 - (a) full details of the existing foul sewer traversing the site within the area now proposed for development ;
 - (b) how scale of development provides for adequate building clearances from the existing sewer ;
 - (c) specific details of surface water arrangements and disposal ;
 - (d) existing and proposed uses for the existing and proposed structures.

NOTE : The applicant must consult with and agreed these matters with the Sanitary Services Department before submitting any further information.
