1. The proposed development would contravene materially a condition attached to an existing planning permission, viz. Condition No. 1 of decision No. P/55/77, dated 10/1/77 (Reg. Ref. K. 2722).
2. The proposed development would encroach upon the lands reserved for a junction between the local distributor road and the proposed Green Route at this location, for which plans have not yet been finalised, and upon the open space adjoining this junction.
