CONDITIONS

1. Subject to the conditions of this permission, that the development be carried out and completed strictly in accordance with the plans and specification lodged with the application.
2. The structure shall be removed from the site on or before 1.8.1984 unless permission for its retention has been granted by Dublin County Council or An Bord Pleanala on appeal.
3. That the requirements of the Chief Wire Officer be ascertained and strictly adhered to in the development.
4. That the requirements of the Chief Medical Officer be ascertained and strictly adhered to in the development.
5. That the drainage arrangements including the disposal of surface water be in accordance with the requirements of the County Council, Sanitary Services Department.

REASONS FOR CONDITIONS

1. To ensure that the development shall be in accordance with the permission and that effective control be maintained.
2. To enable the effect of the development on the amenities of the area to be reviewed, having regard to the conditions then obtaining.
3. In the interest of public safety and the avoidance of fire hazard.
4. In the interest of health.
5. In order to comply with the requirements of the Sanitary Authority.
