1. Further information is required which would provide for the following:-
 - (a) Specific details of the applicant's total land holding in the area clearly shown on a plan to a scale of 1:2500. Details of the applicant's family holdings should also be shown. The areas in acres are to be indicated.
 - (b) Specific evidence of the applicant's need for a dwellinghouse in this high amenity area.
 - (c) Specific evidence that adequate and satisfactory septic tank drainage and necessary percolation areas together with an adequate and satisfactory potable water supply can be provided.

The applicant must consult and agree these matters with the County Council before submitting any further information.
