before the application can be considered under the Local Government

information must be submitted in quadruplicate:-

- i. Further information is required which should provide for -
 - (a) specific details of the proposed wall foundations in relation to the adjoining residential development;
 - (b) adjustments and alterations to the wall location and a possible reduction in length for the purpose of facilitating free movement of the Council's Parks Department for maintenance and upkeep of the open space areas.
