With reference to your planning application received here on the 25th April 1979 in connection with the above, I wish to inform you that before your application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 that the following additional information must be submitted in quadruplicate:-

1. Further information is required which should provide for the following:
  - (a) Adequate and satisfactory evidence that the site proposed is suitable for septic tank drainage, including soil suitability and adequate percolation areas. Satisfactory evidence is also required that an adequate and potable water supply can be provided.
  - (b) Details including area in acres of the applicant's family land holding in this area.
