With reference to your planning application received here on the 23rd April, 1979 in connection with the above, I wish to inform you that before your application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate :-

1. Details of an acceptable septic tank design plan - including type and location - and evidence that the site proposed is suitable for septic tank drainage. It is recommended that a septic tank design similar to that illustrated in the IIRS publication S.R. 8 1975 should be submitted.
2. Satisfactory evidence is also required that an adequate and potable water supply can be provided.
3. Details of a satisfactory scheme of landscaping, tree planting, tree preservation and boundary treatment including the proposed programme for the carrying out of such works.
