2. Car parking spaces to be properly set out and to be painted using a durable paint.
3. That the detailed landscaping scheme, including the west boundary adjoining existing dwellinghouses and out-buildings, as set out on Drawing No. 280X/24a - Scale 1/500 dated 27/1/75, submitted to County Council on 1/9/75 and forming part of the plans approved by order No. P/3031/75 dated 30/9/75 - Reg. No. H.1729, be agreed and completed immediately.
4. That the pedestrian path shown in blue on Drawing No. 1976-18-1 submitted to the Council on 28th March 1979 be continued and completed along the entire site frontage.
