With reference to your planning application received here on the 26th March 1979 in connection with the above I wish to inform you that before your application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate:-

1. Further information is required which should provide for
  - (a) specific evidence of soil suitability for septic tank drainage including adequate and satisfactory percolation areas together with satisfactory evidence that an adequate and potable water supply can be provided.
  - (b) The applicant's specific proposals for the removal of all existing dumped materials and residue on these lands together with the satisfactory reinstatement.
  - (c) Details of proposed access arrangements to the new dwelling house together with the applicant's specific proposals for landscaping.

Note: The applicant must agree these matters with the County Council before submitting the information.
