Dear Sir,

With reference to your outline planning application received on the 15th February, 1979, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following information must be submitted in quadruplicate:-

1. Further information is required which should provide for the following:-
 - (a) specific details of the applicant's total land holding in the area, clearly shown on a plan to a scale of 1:2500. Details of the applicant's family holdings should also be shown. The areas in acres are to be indicated;
 - (b) specific evidence of the applicant's need for a dwellinghouse in this high amenity area;
 - (c) specific evidence that adequate and satisfactory septic tank drainage and necessary percolation area, together with an adequate and satisfactory potable water supply can be provided.

Note:- The applicant must consult and agree these matters with the County Council before submitting any further information.
