In pursuance of its functions under the above mentioned Acts the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order, P/ **1362/79,** dated **10th April, 1979,** decide to refuse:

For **proposed change of use of public open space to private open space adjoining No.** ..
17, Ard Macha, Oldbawn, Tallaght,

for the following reasons:

1. The development proposed would contravene materially a condition attached to a previous permission, i.e. condition No. 1 of Order No. P/871/74, dated 29/3/74 (Reg. No. G. 151) and condition No. 1 of Order No. P/885/74, dated 2/4/74, (Reg. No. G.185) and would not be in accordance with the proper planning and development of the area.
2. The proposed development, which envisages the diminution of the previously approved public open space area associated with the Old Bawn Residential Estate, would not be in accordance with the proper planning and development of the area.
