Dear Sir,

With reference to your application for planning permission received on the 7th February, 1979, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following information must be submitted in quadruplicate:-

1. Further information is required which should provide for -
  - (a) specific details of the existing carparking arrangements related to the existing floor areas, together with adequate and satisfactory additional offstreet carparking related to the scale of development now proposed to the Development Plan standards.
  - (b) Specific details of the existing labour force, male and female, and the anticipated increase in the number of workers, both male and female.
  - (c) Specific details of the existing and proposed vehicular traffic movements to and from the site, together with the types of vehicles involved.
  - (d) specific details of adequate and satisfactory access arrangements to and from the site, including adequate traffic vision splays, to the Roads Department requirements.
  - (e) Details of the existing and proposed water consumption, together with the applicant's specific proposals for providing 24-hour water storage. Specific details of any industrial effluents and the applicants' proposals for waste material disposal.

Note:- The applicants must agree these matters with the County Council before submitting any further information.
