In pursuance of its functions under the above mentioned Acts the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order, P/ **958/79**..... dated **7/3/79,**..... decide to refuse:

For..... **retention of 2 freestanding advertising panels and one gable wall advertising panel**
..... **at Redcow Inn, Naas Road,**
for the following reasons:

1. The retention of these advertising panels would endanger public safety by reason of traffic hazard, because of the unacceptable proliferation of advertising hoardings and signs adjoining this section of the Naas Road dual-carriageway, together with their competition with existing road signs on this heavily trafficked National Primary Route.
2. The two freestanding advertising hoardings are incorrectly located on the plans submitted.

When an appeal has been duly made and has not been withdrawn An Bord Pleanala will determine the application for permission as if it had been made to them in the first instance.
