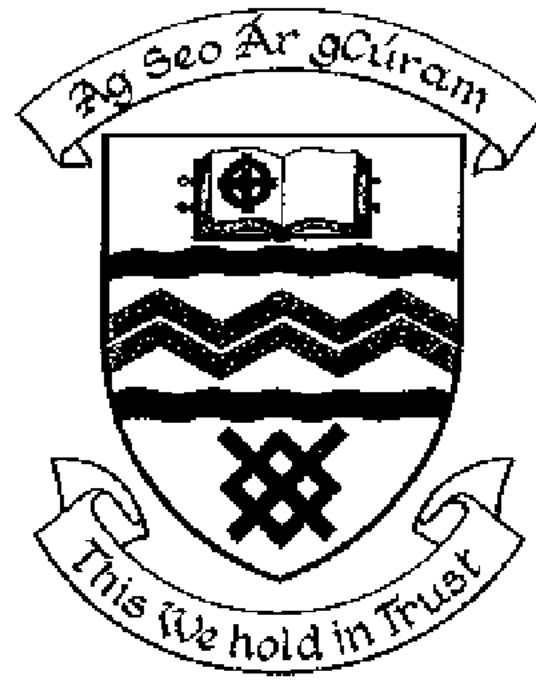

Reasons

- 1 The proposed development is visually obtrusive by virtue of the unsympathetic character of the external metal sheeting, the height of the proposed wall and the size of the garage, and would seriously injure the residential amenity of the property in the vicinity, contrary to the zoning objective 'A' "to protect and or improve residential amenity", of the South Dublin County Development Plan 1998.
