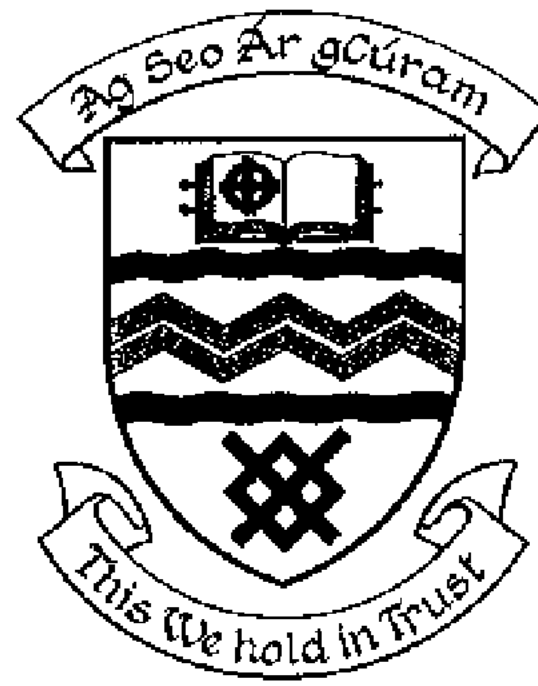

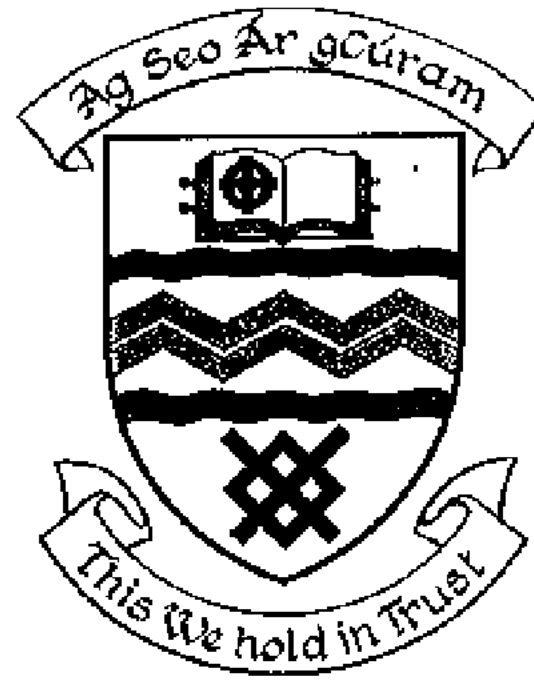
Dear Sir/Madam,

With reference to your planning application, received on 24/08/99 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

- 1 The applicant is requested to submit revised plans clarifying whether the elevational view referred to in the submitted plans as the rear elevation is in fact the front elevation.
- 2 The applicant is requested to submit revised plans showing all external materials to match those of the existing dwelling.
- 3 The applicant is requested to confirm that no part of the proposed development will encroach on or oversail neighbouring property without the agreement in writing of the property owners.
- 4 The applicant is requested to clarify what the half circular area shown in front of the porch on the the ground floor plan is.
- 5 The applicant is requested to submit plans showing both side elevational views instead of just one side elevation.
