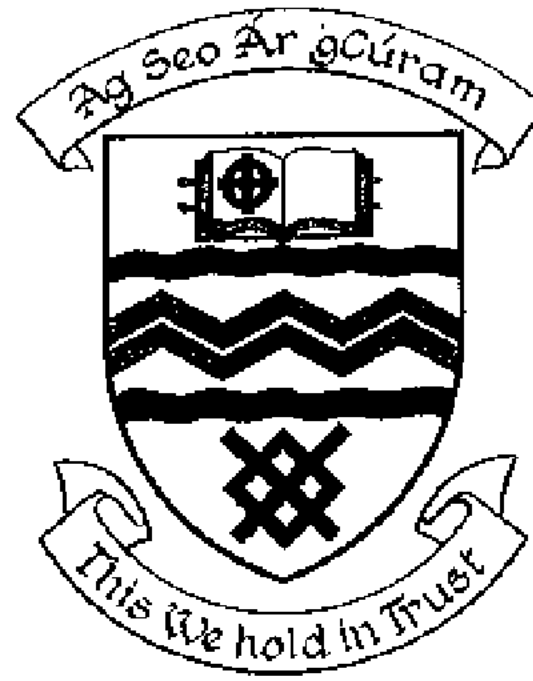

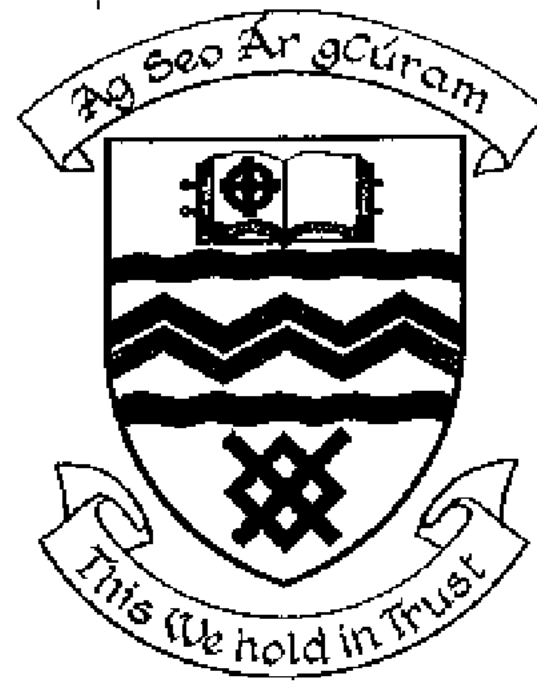

Reasons

- 1 It is considered that the proposed widening of a driveway which is already 3 metres wide, the hard surfacing of a further area of grass verge, the removal of a street tree and hard surfacing of the entire front garden area would be detrimental to the visual amenities of the area and as such is not in the interests of the proper planning and development of the area.
- 2 The proposed development would set an undesirable precedent for other similar developments which would in themselves and cumulatively not be in the interests of the proper planning and development of the area.
