Reasons

- 1 The proposed development, by virtue of its excessive depth and height and proximity to neighbouring property would seriously injure the amenities of property in the vicinity. It would therefore be contrary to the zoning objective for the area which is Objective A "To protect and/or improve residential amenity", as set out in South Dublin County Development Plan 1998.
