1. Further information is required which should provide for:-
 - a) Specific evidence of soil suitability for septic tank drainage, including all necessary percolation areas for the purpose of ensuring satisfactory foul drainage proposal. The applicant's specific proposals for providing an adequate land area for these purposes are also required.
 - b) Specific evidence that an adequate and satisfactory water supply system can be provided.
