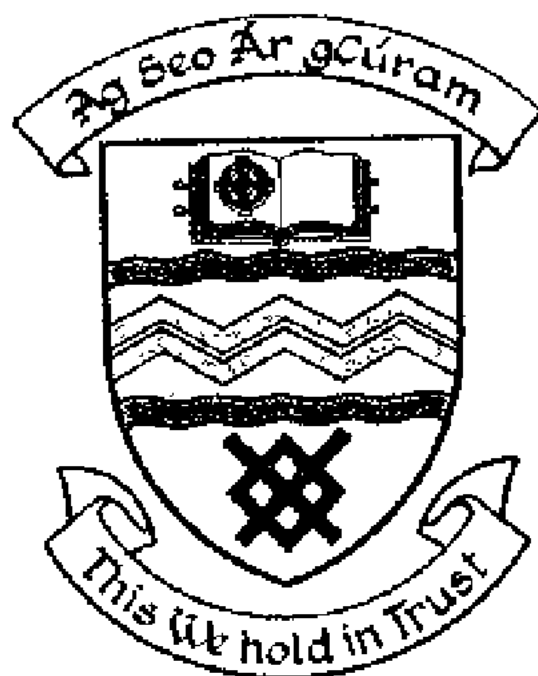

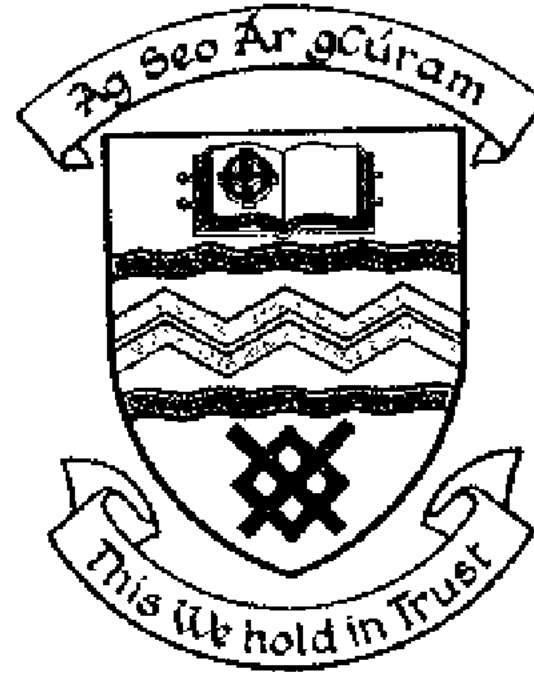

REASON:

- 2 That bedroom No. 4 be omitted from the development. Revised drawings in this regard shall be submitted for the agreement of the Planning Authority prior to the commencement of the development.

REASON:

In the interest of the protection of residential amenity.

- 3 That the entire premises be used as a single dwelling unit.

REASON:

To prevent unauthorised development.

- 4 That all external finishes harmonise in colour and texture with the existing premises.

REASON:

In the interest of visual amenity.

- 5 That the water supply and drainage arrangements, including the disposal of surface water, be in accordance with the requirements of the County Council.

REASON:

In order to comply with the Sanitary Services Acts, 1878-1964.

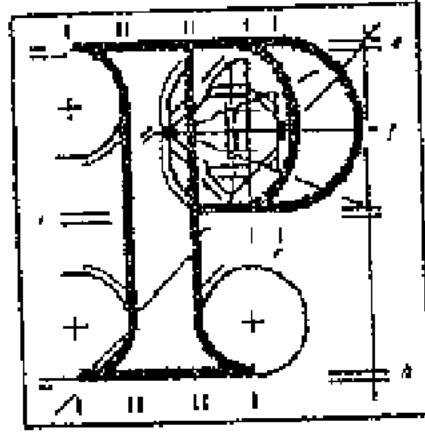
