With reference to your planning application received here on 12/10/'83, in connection with the above, I wish to inform you, that before the application can be considered under the Local Government (Planning and Development) Acts, 1963-1983 the following additional information must be submitted in quadruplicate:-

1. In view of the fact that four houses have already been built on Mr. Murray's land applicant should submit details of his need for a further house in the area.
2. The site of the proposed development is located in an area zoned "B" "to protect and provide for the development of agriculture". Clarification is required as to how the proposed development could be considered to be compatible with this zoning objective.
3. Applicant to clarify his proposals in relation to the sterilisation of the lands remaining from the lands originally sterilised under Condition No. 6 of Register Ref. E.1082.
