

Reasons

- The site is located in an area zoned 'GB' to preserve a greenbelt between development areas in the current County Development Plan. Section 3.3.11 of the Development Plan states in respect of areas so zoned where residential development is concerned, only individual dwellings on lands comprising at least 4 hectares per dwelling and with a road frontage of at least 200 metres will be favourably considered. The current proposed development would contravene materially a development objective of the Development Plan and would be contrary to the proper planning and development of the area.
- Significant issues in relation to the provision of foul drainage in respect of the adjoining golf course development and upon which the current site will depend for the provision of a foul drainage system remain outstanding. A grant of planning permission in the absence of agreement on these issues would be premature, contrary to the proper planning and development of the area, and would be prejudicial to public health.
