



Reasons

- The proposed development will involve construction of a culde-sac road with a substandard turning bay in relation to the number of dwelling units it is proposed to serve. This will give rise to difficult traffic turning movements, potential conflict with on-street parking and with pedestrian movement. The proposed development would therefore endanger public safety by reason of traffic hazard.
- The proposal to re-orientate units 17, 19, 21, 23, 25 and 27 such that they no longer overlook the area of public open space to the north, will undermine the integration of the Ballydowd Manor development with the Willsbrook Woods development to the north, while also failing to provide adequately for personal security. In this regard, the proposed development is considered to conflict with para 3.4.1 of the County Development Plan in relation to residential development standards. The proposed development does not therefore conform with the proper planning and development of the area.
- In view of the density of development proposed, the substandard level of provision of private open space, the failure to overlook the area of public open space to the north, and the inadequacies of the turning bay of the proposed cul-de-sac road, the proposed development will not achieve the desired level of residential amenity for new housing development. The proposed development does not therefore conform with the proper planning and development of the area.
