Reasons

- The proposed development involves accessing the site via an unsurfaced grassed area of open space. In view of the significant distance between the site of the proposed dwelling and the existing surfaced roadway at Airlie Heights, the proposed development would give rise to excessive volumes of traffic along a significant length of open space. This would constitute an inappropriate use of the open space, would undermine its utility and would therefore depreciate the amenity quality of the open space, which serves the residential development of Airlie Heights. The proposed development would therefore seriously injure the amenities of residential property in Airlie Heights.
- The proposed development would establish a precedent for the creation of additional accesses onto this length of open space, further undermining the use of the open space, and would not therefore conform with the proper planning and development of the area.
- The proposed development does not achieve an acceptable degree of accessibility and therefore conflicts with para 3.4.1 of the South Dublin County Development Plan 1998 which spells out the basic requirements for residential developments. The proposal does not therefore conform with the proper planning and development of the area.
