Reasons

- The proposed development would materially contravene zoning objective G of the South Dublin County Council Development Plan 1998 "to protect and improve high amenity areas". The proposed development, by itself or by the precedent which the grant of permission for it would set for other relevant development, would lead to the erosion of the lands zoned to protect and improve a high amenity area which must be protected to provide for the creation of a Dodder Valley Linear Park within the vicinity. Thus the development would be contrary to the proper planning and development of the area.
- The proposed development would materially contravene the policies of the South Dublin County Council Development Plan 1998 regarding developments within areas of High Amenity as set out in policy 2.3.1.iv which states that "within areas designated with zoning objective G, dwellings will only be permitted where the applicant can demonstrate a genuine need for housing in the area and the development is directly related to the area's amenity potential or to its use for agriculture". As the applicant does not fulfil the requirements of this policy, it is considered that the development would be contrary to the proper planning and development of the area.
- The site boundaries and layout shown on drawings submitted with this application indicate that the extensive side garden on the neighbouring dwelling, The Hollow, Spa Well, would be incorporated into the proposed development. The proposed development would thus seriously injure the amenities, or depreciate the value, of property in the vicinity.
- The proposed development would endanger public safety by reason of a traffic hazard or obstruction of road users or otherwise due to the following reasons:
 - (a) The junction of this road with the dual carriageway is next to where the hard shoulder ends and the carriage way widens to 3 lanes approaching the traffic lights on the roundabout. Confusion will be Page 2 of 3

created here for motorists who cannot distinguish between vehicles indicating to turn left into the road or left into the inside lane. This confusion will endanger public safety by reason of a traffic hazard.

- (b) The proposed development by itself or by the precedent which a grant of permission for it would set for other developments, would adversely affect the use of a National Secondary Route by traffic.
- As this road access is a left in left out only, vehicles using it will have to use the Interchange roundabout or the Wellington Road roundabout for turning movements thereby reducing the capacity of these roundabouts.
