

APPEAL by Statoil Ireland Limited care of Kiaran O'Malley and Company Limited of Saint Heliers, Saint Heliers Copse, Stillorgan Park, Blackrock, County Dublin against the decision made on the 27th day of January, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the construction of an extension to an existing retail shop, new façade including new illuminated signage, alterations and addition to existing canopy, new service bay and ancillary works at Ballyboden Service Station, Ballyboden Road, Rathfarnham, Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reason set out in the Schedule hereto.

SCHEDULE

It is considered that the proposed development would result in overdevelopment of a confined site by reason of the scale and intensity of use of the retail unit, inadequate on-site car parking provision and traffic congestion within the site curtilage and on the Ballyboden Road at the entrances to the site. The proposed development would, therefore, endanger public safety by reason of a traffic hazard and would be contrary to the proper planning and development of the area.
